We are pleased to notify you that the Articles of Incorporation for the above-referenced entity HAVE BEEN APPROVED.

You must publish the Articles of Incorporation in their entirety. The publication must be in a newspaper of general circulation in the county of the known place of business in Arizona for three consecutive publications. A list of newspapers is available on the Commission website, <http://www.azcc.gov/Divisions/Corporations/Newspaper-list-for-publishing.pdf>.

Publication must be completed WITHIN 60 DAYS after February 25, 2016, which is the date the document was approved for filing by the Commission. The corporation may be subject to administrative dissolution if it fails to publish. You will receive an Affidavit of Publication from the newspaper, and you may file it with the Commission.

Corporations are required to file an Annual Report with the Commission. Your Annual Report is due on 02/12/2017, and on the anniversary of that date each subsequent year. It is your responsibility to file the corporation's Annual Report by the deadline each year. You can file it electronically through our website at <http://ecorp.azcc.gov>, or you can complete the form online, print it, and mail it in, or you can call the Annual Reports section at 602-542-3285.

Corporations must notify the Commission immediately, in writing, if they change their corporate address, statutory agent, or statutory agent address. Address change orders must be signed by a duly authorized corporate officer. A forwarding order placed with the U.S. Postal Service is not sufficient to change your address with the Commission.

ARTICLES OF INCORPORATION
OF

ARTICLE I
Name

The name of the corporation is MOUNTAIN TRAILS COMMUNITY ASSOCIATION, an Arizona nonprofit corporation (the "Association"). Capitalized terms used herein but not specifically defined shall have the same meaning given to them in the Declaration (as defined in Article IV below).

ARTICLE II
Duration

The duration of the Corporation shall be perpetual.

ARTICLE III
Purpose

To have and exercise any and all powers, rights and privileges which a corporation organized under the Arizona Nonprofit Corporation Act (see A.R.S. § 10-3101 *et seq.*, as may be amended from time to time) may now or hereafter have or exercise.

ARTICLE IV
Character of Affairs

The Association is organized to perform the duties and obligations of the Association as set forth in that certain Declaration of Covenants, Conditions, and Restrictions for Mountain Trails Community Association, recorded in the Official Records of the Maricopa County Recorder, as may be amended from time to time (the "Declaration"). In furtherance of the foregoing, the character of affairs which the Association initially intends to conduct in Arizona is to provide for the orderly development, maintenance, preservation, and architectural control of that certain residential subdivision known as the Mountain Trails Community Association, and to act in furtherance of the common good and general welfare of the community.

ARTICLE V
Statutory Agent

ARTICLE VI
Board of Directors

Until the termination of the Declarant Control Period, the directors of the Association shall be appointed by and may be removed solely by Declarant. After the termination of the Declarant Control Period, or at such earlier time as Declarant relinquishes its rights to appoint the Board, the directors shall be elected by the Members in accordance with the Bylaws.

The number of directors constituting the initial Board of Directors shall be three (3). The names and addresses of the initial directors of the Association who shall serve until replaced by Declarant or their successors are elected and qualified are as follows:

ARTICLE VII
Incorporator

All powers, duties and responsibilities of the incorporator shall cease at the time of delivery of these Articles of Incorporation to the Arizona Corporation Commission.

ARTICLE VIII
Limitation of Director Liability

To the fullest extent allowable under the Arizona Nonprofit Corporation Act (see A.R.S. § 10-3101 *et seq.*, as may be amended from time to time), each director of the Association shall be immune from civil liability and shall not be subject to suit indirectly or by way of contribution for any act or omission resulting in damage or injury if said director was acting in good faith and within the scope of his or her official capacity (which is any decision, act, or event undertaken by the Association in furtherance of the purpose or purposes for which it is formed) unless such damage or injury was caused by willful and wanton or grossly negligent conduct of such director. This provision intends to give all directors the full extent of immunity available under the Arizona Nonprofit Corporation Act (see A.R.S. § 10-3101 *et seq.*, as may be amended from time to time).

ARTICLE IX
Indemnification of Directors, Officers and Agents

The Association shall indemnify any person who incurs expenses or liability by reason of the fact that he or she is or was an officer, director, or agent of the Association. This indemnification shall be mandatory in all circumstances in which indemnification is permitted by law; provided, however, that the Association shall have the right to refuse indemnification if the person to whom indemnification would otherwise have been applicable shall have unreasonably refused to permit the Association, at its own expense and through counsel of its choosing, to defend him or her in the action.

ARTICLE X
Principal Office

The principal office of the Association shall be located at c/o AAM, LLC, 1600 W. Broadway Road, Suite 200, Tempe, AZ 85282.

ARTICLE XI
Membership

The Association shall have members.

ARTICLE XII
Dissolution

Upon dissolution or liquidation of the Association, other than incident to a merger or consolidation, the Association shall pay or adequately provide for the debts and obligations of the Association and otherwise comply with the Arizona Nonprofit Corporation Act (see A.R.S. § 10-3101 *et seq.*, as may be amended from time to time), and the assets of the Association shall be

dedicated to an appropriate public agency to be used for the purposes similar to those for which the Association was created.

ARTICLE XIII
Amendments

These Articles may be amended by the written approval or affirmative vote, or any combination thereof, of sixty-seven percent (67%) of the total authorized votes in the Association; provided, however, that during the Declarant Control Period, Declarant may unilaterally amend these Articles without a vote of the Members and without the consent or approval of any Owners or Members, or any other Person, and any amendment by the Members during the Declarant Control Period shall, in order to be effective, require the prior written approval of Declarant.


